Hunter Douglas certifies that Duette® Architella® honeycomb shades purchased with the qualifying fabrics listed on the following page, manufactured with the UltraGlide®, EasyRise<sup>™</sup>, LiteRise®, or Standard Cordlock hardware operating systems and used in conjunction with double-glazed windows are "Eligible Building Envelope Components" classified as an "insulation material or system" as such terms are defined in Section 4.01 of IRS Notice 2009-53 and, subject to the restrictions set forth below, qualify for the Federal Tax Credit for Non-business Energy Property allowed under Internal Revenue Code Section 25C, as modified by Section 1121 of the American Recovery and Reinvestment Tax Act of 2009, and as further modified by Section 710 of the Tax Relief, Unemployment Insurance Reauthorization, and Job Creation Act of 2010.

The qualifying shades must be inside mounted with no part of the Architella fabric protruding out from the window casement or frame. The qualifying shades with Architella fabric must be installed and used in accordance with the manufacturer's instructions for installation and use of this product.

Finally, the qualifying shades may not have any of the following options or features:

- Motorized operating system
- End mounting
- Outside mounting
- Hold-down brackets
- Two-On-One Headrail design option
- Cut-outs
- Duolite<sup>™</sup> hardware system where one of the two fabric options is a non-qualifying fabric

The qualifying Duette Architella shades referenced, identified, and installed as described herein, meet the prescriptive criteria established by the 2009 International Energy Conservation Code (IECC).
